### DIRECTIONS- From Governors Harbor

**Blue Hole Tour, Paddleboards, and Kayaks Rentals- Heading South on Queens Highway – Drive past Rock Sound Airport and The Market Place and turn right into Frigates Restaurant and Grill, park to the right and we are located in Tiki on the water.**

**Turtle Tour- Center for Training and Innovation** Go South on Queens Highway past Tarpum Bay- keep going 5 miles to Center for Training and Innovation on left hand side. We will meet you in there parking lot on south side of property. Located before Rock Sound airport.

**Schooners Cay, Fishing, and Snorkeling Boat Tour- Davis Harbor** Go south on Queens Highway till it ends in Waterford. Go left and Marina will be on the right approximately 1 mile down. Please go through the marina gate and park under the covered area with picnic tables and building. Your boat will be located in front of the tables.

**Dune Buggy's- Princess Cay-** Drive SOUTH on Queen's Highway. 5 miles south of Rock Sound there is a paved road on the LEFT named "Chris The Fireman Brown Blvd" and a big blue sign for Cotton Bay. Turn LEFT here and go 4 miles to Wemyss Bight. At the first intersection with a paved road turn LEFT.. There will be a ballfield/park on your left just a few yards down. Follow this road all the way to Bannerman Town. When you get into Bannerman Town, follow the paved road when it makes a hard right. Go to end of the paved street and go left on to paved street, go straight to Princess Cay sign and go right to parking area.



Eleuthera is an incredibly friendly place and nowhere is that more apparent than in South Eleuthera. Not sure you're going the right way? Stop and ask anyone and see how welcoming and friendly our Island is!

On occasion we will have to move a tour if the wind is not conducive at these locations. We will only contact you if the location may need to be changed. We assure you we do this with your finest experience in mind. The wind and tides determine where we go with your safety and optimal trip plan in mind. If you do not hear from us we will meet you according to the instructions above and on the website. Please make sure we have a number we can text or call the day of the tour or rental. If we must cancel a tour due to weather, a refund will be given. Often this will not be determined until departure time. Guests who do not show for a rental or tour will not be given a refund. Please make any cancelations in writing 30 days before departure to receive a refund. We hope you understand as considerable resources, time, and staffing go into every tour and rental, especially operating in the Out Islands. **ACKNOWLEDGEMENT OF RISKS,  
LIABILITY WAIVER, RELEASE AND INDEMNITY**

IN CONSIDERATION of being allowed to participate in the tour/activity (the "Tour") provided by **ELEUTHERA ADVENTURE TOURS LTD.** (the "Operator"), I hereby enter into this Acknowledgement of Risks and Liability Waiver and Release (the "Release") with the Operator, for myself and/or any minor children for whom I am the legal parent/guardian or otherwise responsible, and for my/our heirs, personal representatives and assigns:

REPRESENTATIONS AND WARRANTIES

I represent and warrant that (i) I am over the age of 21 years old, (ii) I hold a valid driver's license, (iii) I am physically and mentally able to operate the equipment used in the Tour and to participate in the Tour and (iv) any passengers in the vehicle or equipment which I will be operating on the Tour are at least 10 years of age.

ACKNOWLEDGEMENT OF RISKS

I fully acknowledge and accept that the Tour involves certain inherent risks, which may include, without limitation the following: (1) wind shear, inclement weather, lightning, variances and extremes of wind, weather and temperature; (2) the loss of any sense of balance, physical condition, ability to operate equipment and/or follow directions; (3) collision, rollover, crashes with other vehicles or other hazards; (4) the presence of insects; (5) perils of the sea, harm caused by marine creatures (including bites), acts of fellow participants, entering and exiting the water, boarding or disembarking boats, and activities on the dock; (6) equipment failure or operator error; (6) heat or sun related injuries or illness, including sunburn, sunstroke or dehydration; (8) fatigue and/or dizziness which may diminish my/our reaction time and increase the risk of an accident; and (9) personal injury and/or death .

I fully acknowledge that the Operator may outsource or engage third parties to provide the Tour and/or services relating thereto.

I confirm that I have been trained in the safe use of the type of equipment used in this Tour to my complete satisfaction.
